

#### CASAC Initial Certification 350 Course

Hello! I would like to introduce you to the Helio Health Training Institute!

The Helio Health Training Institute is an approved OASAS Training provider for the delivery of the full CASAC 350 hour training for CASAC Certification.

Taking all four sections (one section at a time) this course will take approximately 18 months to complete. Typically, classes run in the evening.

Please note, in each module, there are additional assignments and tests to complete outside of class time and students are expected to meet grading and attendance standards in order to pass the course. Additional sections may be added to this schedule as needed.

Upcoming class dates for the online and in-person classes are shown on the next page. To register for upcoming classes please complete the application and payment forms at the end of the document and submit them via email to <a href="mailto:Training@helio.health">Training@helio.health</a>.

Please note that completion of 350 certification classes will *not* count toward the work hours requirement that is set by OASAS and varies depending on your qualifications. If you have already submitted an application to OASAS and only require certain parts of a module or modules, we can work with you to tailor the program to meet your needs. Our hourly rates are \$10 for employees and \$15 for the general public. If you only need certain hours, please contact us to discuss schedules and needed hours/sections.

Finally, we recognize that taking these courses is a significant financial investment. We are able to help by offering payment plans should the need arise. In order to access a payment plan please contact the training institute prior to completing this application. Our payment plans are tailored to each student and carry no interest. Payment plans split the cost of each section into monthly payments. Payment plans only run for the duration of each section so if your section runs from September to the following January you will be expected to pay a 10% deposit to secure your place on the course, then make five monthly payment to pay off the balance.

If a payment plan is still beyond your means, you might consider contacting either ACCES-VR or CNY Works to enquire about funding through those organizations. Both organizations have funded students in the past. *Please note if using a third party payer (e.g. ACCES-VR) you need to attach a payment verification letter to this application for it to be processed.* 

Unfortunately, as a private training institute we are unable to accept other student loans to cover the cost of CASAC training at this time.
