## CASAC Initial Certification 350 Course

Hello! I would like to introduce you to the Helio Health Training Institute!

The Helio Health Training Institute is an approved OASAS Training provider for the delivery of the full CASAC 350 hour training for CASAC Certification.

Please note, in each module, there are additional assignments and tests to complete outside of class time and students are expected to meet grading and attendance standards in order to pass the course. Additional sections may be added to this schedule as needed.

Please note that completion of 350 certification classes will **not** count toward the work hours requirement that is set by OASAS and varies depending on your qualifications. If you have already submitted an application to OASAS and only require certain parts of a module or modules, we can work with you to tailor the program to meet your needs. Our hourly rates are \$12 for employees and \$17 for the general public. If you only need certain hours, please contact us to discuss schedules and needed hours/sections.

Finally, we recognize that taking these courses is a significant financial investment. We are able to help by offering payment plans should the need arise. In order to inquire about a payment plan, please indicate this when completing this application. Our payment plans are tailored to each student and carry no interest. Payment plans split the cost of each section into monthly or bi-weekly payments. Payment plans only run for the duration of each section (e.g. if your section runs from January until May, you will make six monthly payments, starting with 30 days prior to the start of classes.)

If a payment plan is still beyond your means, you might consider one of our grant opportunities, or contacting either ACCES-VR or CNY Works to enquire about funding through those organizations. Both organizations have funded students in the past. *Please note if using a third party payer (e.g. ACCES-VR) you need to attach a payment verification letter to this application for it to be processed.*

Unfortunately, as a private training institute we are unable to accept other student loans to cover the cost of CASAC training at this time.

# **PAYMENT OPTIONS EXPLAINED**

## **Employee Scholarship (Helio Health Staff Only)**

Programs of Helio Health may cover the cost of the training. Applicants need to speak to their direct supervisor to discuss this option as scholarships are available on a case-by-case basis and must be supported by the program budget.

Applicants are required to work for Helio Health, Inc for one (1) year after completing all 350 hours of education. If the staff person does not, they are responsible for repayment.

## **Employee Payroll Deduction (Helio Health Staff Only)**

Employee rate for training is taken out of your bi-weekly paycheck over the course of the the training program. Total cost will vary, but on average for all four (4) sections over a fourteen (14) month time frame, the cost is roughly \$120.00 per paycheck.

Deductions will start the paycheck prior to the start of your training and will conclude the paycheck prior to your last class.

## **Self-Pay via Credit/Debit Card or Check**

We offer payment plans to break up the cost of the program into smaller bi-weekly or monthly payments over the duration of the program.

## **Funding via ACCES-VR or Workforce Program**

Students are responsible for securing this payment source. If this applies please let us know so Training Institute staff can connect with your caseworker.

# GRANT FUNDED PROGRAMS

## OASAS SCHOLARSHIP

To qualify, must submit additional documentation. Please reach out to [training@helio.health](mailto:training@helio.health) to obtain the necessary documents:

- Addiction Professionals Scholarship Program Application Form
- Employment Verification Form (for applicants who selected one of the\*\* employment options above)
- Three (3) Reference Forms/Letters of Recommendation on affiliate letterhead clearly indicating the signatory's credentials/title/qualifications to write on the applicant's behalf (Employment Verification Form may be submitted in lieu of one (1) Reference Form/Letter of Recommendation and is REQUIRED for any applicants who are working in an OASAS/OMH/DOH-certified setting and/or within a setting along the addictions continuum of care at the time of application\*\*)
- Personal Statement (for individuals not currently employed in the addictions field\*\*\*).

Priority admissions will be based on current employment status for any applicants who are working in an OASAS/OMH/DOH-certified setting.

## SUPERCARE CASAC Program

### Grant Program Requirements:

- Completion of 350 hour educational program
- 500 hours of onsite internship/training with Substance Use treatment experts. Internship must start no later than 90 days after completion of 350 hours educational course.

**Stipend:** The stipend will be available based on program achievement in several areas of coursework, including the CASAC-T application process and certification
